- I understand that only my spouse is admitted along with me, on retirement; generally and other dependants would be admitted subject to other conditions being satisfied.
- I certify that I am not availing Medical Facilities from any other source and that I continue to have the Citizenship of India.
- I understand that on superannuation/invalidation, I can avail the benefits of a serving member during the succeeding calendar month of my superannuation/invalidation, without additional contribution for the said succeeding month. Hence, I shall pay the subsequent contribution as a Retired member, accordingly.
- I shall furnish the required details every year in March and changes, if any, during the year.
- I am not drawing the fixed Medical Allowance of Rs.100/-p.m. (for outdoor treatment) separately along with my pension.

I understand that myself and my family members can avail the treatment only in Pune, normally. **I also understand that I am not eligible for reimbursement of OPD treatment taken outside Pune and I can have IPD treatment only at Govt./ Municipal Hospitals/AMA (i.e. CSMA) and subject to reimbursement as per KEM Hospital, Pune schedule.**

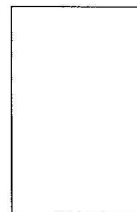

## NCRA-TIFR CONTRIBUTORY MEDICAL SCHEME

### BRIEF EXTRACT OF RULES



#### 1. ELIGIBILITY

Staff members holding regular posts in the academic, scientific / technical and administrative/ auxiliary streams; including Visiting Fellows [PDF] / Visiting Professors / Visiting Scientists; Project Appointees [if their offer provides for medical scheme membership]; all trainees for regular posts, but on stipend, involving absorption in appropriate scale, on successful completion of training and with bond liability; families of such trainees not eligible during training period; Research Scholars [but not their family members].

2. **Family:** Eligible family members will include: (a) Spouse of the employee;

(b) children, step children or legally adopted children, up to 25 years of age, restricted to two\*; children beyond the age of 18 years and up to 25 years, will be eligible for continuation, provided they are not gainfully employed; part time employment, if the same is certified to be so, by the employer and monthly income does not exceed Rs.4000/- is not considered gainful employment as also, any Academic / University stipends, scholarships/ free-ships.

*\* Three [first three] if registered prior to 1.2.1998.*

(c) Physically / Mentally challenged children shall be eligible for the benefits, till such time they are dependent on the prime beneficiary, provided the disability is certified to exceed 40% for physically & above "mild retardation" for mentally challenged.

Note: Married, divorced or otherwise legally separated and widowed daughters, even though dependent on the employee, are not eligible for benefits under the scheme.

(d) Parents, wholly dependent on the prime beneficiary whose combined monthly recurring income is not more than Rs.4000/- (if pension, excluding pensioner's relief), from all sources (include income from pension, land holdings, house, dividends, interest income from fixed deposits, securities, bonds etc) will be eligible if they normally reside with him/her. They should not be away from the residence of employee for more than 90 days in a calendar year. Also, prior to request for registration on each occasion, parents should have actually resided with employee for a minimum period of 30 days. Ration card / residential proof with the same address as that of the employee is a must.
